### **Join ICAEW as an ACCA member | Members of other ...**

ACCA's practising regulations are very, very strict and you're really limited to bookkeeping until you get a PC. Many compare ICAEW's PC requirements to ACCA but the reason ICAEW is "easier" (for want of a better word) is that the relevant work experience is gained via the training contract whereas with ACCA no training contract is required but you have to complete your post-qualified experience via the Practising Certificate Training Record which is then scrutinised by ACCA's Authorisations ...
